FINANCE

1) REPORT OF FINANCE COMMITTEE MEETING HELD 15TH JANUARY 2015

Committee members had previously been circulated with a copy of the Report from the Finance Committee meeting held on 15th January 2015, for information only.

2) TO RECEIVE REPORT OF FIVE YEAR PLAN MEETING HELD ON 14TH DECEMBER 2015

7) TO CONFIRM GRANT PAYMENT TO LLANILLTUD FAWR IN FLOWER RE; BOVERTON **ROAD REGENERATION**

Committee members had previously been circulated with a copy of a Grant Application form submitted by Llanilltud Fawr in Flower, as previously resolved by Full Town Council on 29th May 2014.

RESOLVED: That a sum of £450 be forwarded to Llanilltud Fawr in Flower from the Boverton

Road Regeneration Project.

8) TO DISCUSS QUOTATIONS RECEIVED FOR INSTALLATION OF BONDED MULCH TO PLAY AREA ON RECREATION GROUND USING FUNDS FROM CONTINGENCY AND OLD **SCHOOL BUDGET**

Committee members had previously been circulated with quotations received for the installation of bonded mulch under the play equipment on the recreation ground. It had been recommended by the Five Year Plan that the monies for this could come from the contingency and old school budget so that it works could be completed as soon as possible during this financial year, ensuring the equipment is fit for purpose.

RESOLVED:

The quotation received from GB Sports and Leisure in the sum of £4899.38 + vat be accepted, for installation of mulch to the basket swing, whirl, freerider, tornado and whizzer. The groundworks under the zipwire and climbing frame be reviewed at a later date.

It was also noted that the company recommended the laying of stone dressing to prolong the life of the mulch due to the drainage situation on the recreation field. The Town Clerk confirmed she had spoken to the Vale of Glamorgan playground inspector and he agreed with this recommendation

RESOLVED: That an additional £1,966.50 + vat be accepted for the laying of stone dressing.

The Town Clerk was asked to clarify the warranty on the mulch.

FINANCIAL YEAR 2016/17

9) TO DISCUSS FIVE YEAR PLAN AND PROPOSED GRANT APPLICATIONS

Committee members had previously been circulated with a copy of the current and proposed Five Year Plan, as well as copies of 2 grant applications received for events to be held in the Town. Members were informed that the Five Year Plan committee had put forward a recommendation that these events be supported in the next Financial Year.

That the funds do not be released until the beginning of October.

11) TO DISCUSS QUOTATIONS RECEIVED FOR REPLACING ROOF ON OLD SCHOOL **USING BALANCE OF BUILDING ACCOUNT**

Committee members had previously been circulated with a copy of quotations received for the replacing of the main roof on the Old School. Councillor Foster reminded members that the monies for these works would come from the Buildings Account, which the Town Council had been paying monies into over the past 4 years to cover the cost of replacing the roof.

RESOLVED: The quotation received from C&A Scaffolding be accepted in the sum of £34,200+vat, for works to take place during the summer of 2016.

12) HIRING FEES

Committee members had previously been circulated with a copy of the hiring fees for premises and recreational facilities, cemetery and allotments. Councillor Foster informed members that the Five Year Plan had recommended that the fees do not be increased.

i) Premises & Recreational

Committee members had previously been circulated with copies of the current hiring fees.

That all premises and recreational hiring fees not be increased and remain the RESOLVED: same for year commencing 1st April 2016.

ii) Cemetery

Committee members had previously been circulated with copies of the current Cemetery charges and the proposed Cemetery charges.

That the Cemetery charges not be increased and remain the same for year RESOLVED: commencing 1st April 2016.

iii) Allotments

Committee members had previously been circulated with a copy of the Allotment rents.

RESOLVED: That the Cemetery charges not be increased and remain the same for year commencing 1st April 2016.
