### **WEST WARD**

2016/01323/LBC

Location: Old Place, Castle Street, Llantwit Major

Proposal: Extension of existing Grade II listed two-storey house located within the Llantwit Major Conservation Area. The alterations comprise new roof lights and French doors to existing north rear wing and replacement of existing lean-to east extension with a larger gable roofed extension

**Objections:** LMTC Planning Committee noted the following objections to this development:

- 1) Changing the character of a listed Building within a Conservation Area. (Refer to SPAB Correspondence sent to Mr Peter Thomas).
