# To discuss Agenda Brief re update on Tennis Court Surface

The Town Clerk confirmed that a deep clean of the court surface, as requested by the Contractors, had been undertaken prior to Lockdown and a further site visit had been arranged for the 30<sup>th</sup> June 2020 where it was hoped a final agreement could be made regarding the deterioration of the macadam surface

### To discuss Llantwit Major Bowls Club guidance for members re Covid 19

Councillors had previously been circulated with documentation dated 22<sup>nd</sup> June 2020 recommended guidelines for Llantwit Major Bowls Club during the Covid 19 pandemic. Councillors congratulated the Bowls Club on producing a comprehensive Risk Assessment re their guidelines during Covid 19.

**RESOLVED**: That the Town Council give permission, subject to the implementation of the above guidelines, for Llantwit Major Bowls Club to reopen the Bowling Green to members effective from 1<sup>st</sup> July 2020.

### 569. WEST STREET POOL

#### To discuss email from resident re West Street Pool

Councillors had previously been circulated with an email letter dated 8<sup>th</sup> June 2020 from a resident, reference West Street Pool. Councillor Powell emphasised to Councillors that West Street Pool was a natural wildlife pool which was maintained to a high standard by the Town Council. He stated that West Street Pool was a Grade 2 listed structure and he was against putting any additional sign around the stonework.

Councillor John advised Councillors that he was delighted re the recommendation that 4 Vale Councillors will be retained in Llantwit Major.

#### **To discuss Covid 19 Town Centre Resilience Forum**

Councillors had previously been circulated with an email dated 18<sup>th</sup> June 2020 re details of the Covid 19 Town Centre Resilience Forum. Councillor Thomas confirmed that he and the Town Clerk had attended virtual meetings with representatives of the Vale of Glamorgan Council to discuss ways to 'open' the Town Centre when lockdown restrictions are lifted. The Vale of Glamorgan Council, following a survey of Llantwit Major, stated in the email that as the main shop frontage along Boverton Road, associated with The Precinct, is within private ownership it is the responsibility of the owner and traders to ensure social distancing measures are adhered to. The Vale of Glamorgan Council was proposing to suspend some street parking along Boverton Road, west of the second zebra crossing to the junction with Commercial Street to enable adequate social distancing for pedestrians and access for local businesses. Noted.

# 571. MISCELLANEOUS

### To discuss Agenda Brief re refurbishment of Blue Plaques around Llantwit Major

Councillors had previously been circulated with an Agenda Brief re the refurbishment of 13 blue plaques around Llantwit Major. Councillors were given details of costings for refurbishing the plaques. Councillors were informed that there would be additional costs to remove and reinstall the plaques, transport costs and to cover breakages etc.
