703. TO ELECT TOWN MAYOR.

Councillor G Thomas welcomed everyone to the Annual Meeting.

Councillor G Thomas asked for nominations for Town Mayor for the year 2021/2022. Councillor D Foster nominated Councillor D Powell to be the Town Mayor. Councillor Foster stated that Councillor Powell was born and bred in Llantwit Major and since being elected to the Council has become a valuable member of the team. He has become a bit of a planning expert, learning about the complex planning policies and studying approvals and refusals. Councillor Foster said he had no doubt that David and Gill's ancestors would be looking down today and would be immensely proud of them both being nominated Town Mayor and Mayoress. Councillor Foster felt that David and Gill would represent the Council and the Town in an exemplary manner. This was seconded by Councillor G Wilkie.

RESOLVED: That Councillor D Powell be duly elected Town Mayor for 2021/2022.

The Chains of Office were invested to Councillor D Powell.

Councillor D Powell then proceeded to read and sign the oath as newly elected Town Mayor.

Councillor D Powell thanked Councillor Foster for his kind words and to the Councillors for considering him worthy enough for the post of Town Mayor. Councillor Powell stated he would do his best to represent the Town and its residents. He said it was a privilege and honour to be elected as Town Mayor, to the Town that his family had lived in all their life. He would endeavour to help the town evolve over the forth coming year, serve the community and uphold the good work undertaken by the past Town Mayor.

Councillor Powell said he was still learning in the role and looked forward to this new challenge.

Councillor Powell thanked Councillor Thomas and his consort, Mrs Glenys Thomas, for all their hard work during their time in Office. He stated Councillor Thomas had conducted Council meetings efficiently and professionally during a very difficult time. Councillor Powell expressed his disappointment for the past Town Mayor at not being able to undertake functions and events during his year due to the Coronavirus pandemic.

Councillor D Powell confirmed his nominated charities for the year would be the youth organisations of Llantwit Major.

His consort during his time as Town Mayor will be his wife Mrs Gill Powell.

Councillor G Thomas was presented with the heraldic shield and past Mayor's badge.

Councillor G Thomas addressed the Meeting. He said that it had been a great honour to be Mayor. Despite the pandemic, the Council had managed to keep Council Business going. He stated the Annual Report showed how much the Council had achieved during this challenging time. As Town Mayor he stated he had only been able to attend 3 engagements and undertaken 2 radio interviews due to the pandemic. Councillor Thomas stated that the Council had received an excellent report from the Standards Committee re the conducting of Town Council Remote Meetings.

Councillor Thomas expressed his heartfelt thanks to all Councillors and Staff during his term in Office and offered his best wishes to the Town Mayor and his consort for the forthcoming year.
