## **Introduction By Town Mayor**

#### **LLANTWIT MAJOR TOWN COUNCIL – MAYOR'S ANNUAL REPORT**

Welcome to the Mayor's Annual Report for 2021/2022. This year has again been dominated by the Covid-19 pandemic, although the work of the council for the residents of Llantwit Major has continued albeit under the restrictions imposed by Welsh Government. It has been a very frustrating term of office as Mayor for myself with a number of events having to be cancelled at the last minute due Covid restrictions, but nevertheless one that I have enjoyed. Fortunately, I was able to attend more events than last year's Mayor Cllr. Gerwyn Thomas who had an extremely difficult year under more severe restrictions.

The use of virtual meetings has now become part and parcel for the running of the Town Councils affairs with all the meetings up until the end of March done this way. Hybrid meetings will now become normal working practice for Councils throughout Wales. Llantwit Major Town Council has recently purchased equipment to enable this to happen within Council meetings. I was delighted to have chaired the March full Town Council's meeting in this way, even though it was more challenging to manage. It also made it possible for all councillors to be able to attend the meeting without the worry of this dreadful virus.

One event that I did manage to hold for my nominated charities was a garden party which was held in July. Fortunately, the weather was beautiful on the day which helped to make the event a great success. Strict Covid rules limited numbers, but all Guidance was followed to ensure everyone's safety.

A Carol service in a barn with cattle, sheep and a donkey had been organised and was a complete sell-out but unfortunately had to be cancelled at the last minute because of the increased risk of the Omicron variant. Nevertheless, the animals still came into the barn to be sung to by myself and my family.

I would like to express my gratitude to the kind sponsors and supporters of my events who have helped me to raise nearly £2,000 for Llantwit Major youth charities.

My wife and I were extremely honoured to be asked to attend the Royal Air Force "Wales and the Battle of Britain Historical Exhibition" which took place in Cardiff City Hall in September. The deep association between RAF St Athan and Llantwit Major made this event extra special. RAF St Athan has played a major role in the town's growth and culture throughout the past 84 years and a large part of the town's population will undoubtedly have had some involvement with the camp at some point.

Again, this year's Remembrance service was affected by Covid but we did manage to have a small parade with restricted numbers from various organisations marching and laying wreaths at the Cenotaph.

It was a great disappointment to me that I could not hold a Civic Service to mark my year as Mayor of this historic town. As someone who has been born, raised and lived in the town all my life it was something that I was really looking forward to. Various dates were considered, but with Covid restrictions, staff numbers and the upcoming May Elections it proved impossible to arrange. However, I did have the privilege to meet other dignitaries at several other Civic Services throughout the Vale that did manage to take place.

The Town Council has responsibilities of looking after many areas and buildings throughout the town of Llantwit Major. Councillors have again put in an immense amount of work and effort into the various committees in order to maintain and improve the facilities within the town. I am most grateful to them for this and the help that they have given me throughout my term of office.

Some of the year's achievements have been installing a new sound system and hearing loop in the Llantonian Hall, more adult exercise equipment and signage on the recreational field and a new fire alarm system in the sports pavilion. New signage promoting Llantwit Major as a Fairtrade was also purchased and placed at the entrances to the town. An extensive topple testing survey was also carried out in Boverton cemetery. This year also saw the first wedding in our newly refurbished Council chambers with more bookings for the coming year.

A new lighting system to illuminate our beautiful Town hall has been purchased and will installed in April/May. The clock will also be fully cleaned and repaired plus we will hopefully have the chiming mechanism working again.

To be able to manage and maintained all these facilities throughout this difficult year also needs a capable workforce. What an amazing team of staff in the Town Hall we have, without them none of this great work could have been achieved.

Throughout my term of office, I have met many new residents who have moved to Llantwit Major and have said what a wonderful place it is to live. A beautiful, well maintained, friendly and welcoming town are just some of the things I have been told. If Llantwit Major Councillors have helped to contribute towards some of these wonderful comments, then I feel we have achieved our reasons for wanting to become Town Councillors.

The report covers the municipal year of Councillor D Powell term in office as Town Mayor and Chair of the Council, which started in May 2021.

The year has once again been defined by the Coronavirus Pandemic with the world still dealing with this unprecedent virus that has impacted on everyone, so dearly.

The Annual Report this year again therefore must reflect heavily on the Covid 19 Pandemic. Although lockdown restrictions started lifting this year the legislation from the Coronavirus Act 2020 defines how Councils must continue to operate. There were further periods of working from home, holding remote Council Meetings, and the further closing and reopening of council facilities whilst adhering to social distancing and Welsh Government Covid 19 guidelines.

### **History of Llantwit Major Town Council**

Llantwit Major Town Council serves a population of approximately 14,500. It is the third largest Town/Community Council within the catchment of the Vale of Glamorgan Council and is still growing with the new housing developments being built around our surrounding town.

The Town Council was formed in 1974 although before this Llantwit Major was served by a Parish Council and this can be traced back to 1894. The first Town Council Mayor was Mr A C W Davies (1974-75).

Llantwit Major (Llanilltud Fawr) is steeped in history with it being named as the site of the main church of Illtud, one of the founding Saints of the monastic settlements of the 5th century AD in Wales. Nowadays Llantwit Major is surrounded by countryside and has excellent transport links, as well as to the South the Bristol Channel and the Heritage Coastline.

Llantwit Major Town Council is made up of 14 elected Councillors representing 4 wards, West Ward, South East Ward, North Ward and Boverton Ward. There is a team of 6 staff working both full time and part time delivering services on a daily basis.

The Council is responsible for many facilities, including 5 community buildings (2 of which are listed), bowling green, tennis courts, 2 playparks, 2 open spaces, recreation field, ornamental pond, cemetery and allotment site. The Town Council are in the process of taking over Stradling Park, an overgrown area in the centre of the town, under a 99-year lease from the Vale of Glamorgan Council. Thus, creating an additional open space/recreational area which can be developed for the community.

In 2013 the Town Council resolved to work in partnership with the Vale of Glamorgan Youth Services and provide a Youth Council. The Town Council have budgeted to continue to support a Youth Council in the town. They attend Full Town Council Meetings and help at events in the town.

# A prosperous Llantwit Major

#### What we did well

- Although full lockdown ended on the 19<sup>th</sup> February 2021 the financial impact on our public buildings remained with continuing restrictions including face coverings, limited numbers and social distancing in place. Despite these restrictions the Town Hall and Llantonian Hall were able to open to their regular Hirers. In early 2022 the compass Building and Council Chamber re-opened and casual bookings and increased numbers were permitted within all our Council buildings.
- Just Be Counselling, 2 Nurseries and the History Society continue as long-term tenants at the Old School Building.
- The Town Council hosted a number of weddings. These were the first civic services undertaken at the Council Chambers since the Council obtained an official licence for the Chamber to be used as a venue for civic services.
- A new Fire Alarm System was installed in the sports Pavilion ensuring the safety for the Bowls Club and external organisations that use the Sports Pavilion.
- A hearing Loop System was installed in Llantonian Hall to work alongside the Sound/PA system installed in 2020. Thus, providing a mechanism for those with hearing difficulties to be able to attend and enjoy functions in Llantonian Hall.
- A Vale of Glamorgan Council Community Grant was successfully obtained to provide two new Cenotaph Benches / two external notice boards on the Recreation Field and the installation of 3 additional pieces of Play Equipment on the Playing Field.
- The Town Hall Office remained open throughout 202/22 providing information / support/council and tourist information to the general public and residents of the town.
- The website is always maintained and updated in accordance with latest regulations / requirements. The online site promotes the Town Council Facilities, functions and businesses. The online booking facility allows the general public to enquire of the usage of any of the Town Council Buildings.
- The Town Council continue to fund the Llantwit Youth Council to provide young people an opportunity to gain experience of Local Council and undertake community work which can assist with our next generations Welsh Baccalaureate and College/University applications.
- Provided financial support and assistance to ensure the success of the 2022
   Christmas Light Illuminations throughout the town.
- Provide financial support and advice / guidance to the Tennis Club whilst they
  undertake a major project to install floodlights on all four tennis courts on the
  Recreation Field.

#### Work more closely with local organisations

- Work more closely with local organisations/ Chamber of Trade / Town Centre
  Development Team / Vale of Glamorgan Council to obtain fundings and resources
  to improve the financial viability and footfall to the town during these challenging
  times.
- With the pandemic restrictions lifting look at using Council facilities to provide community events for the town, to promote our town and increase the number of tourist and business opportunities for our town.
- Offer our children better after school/holiday activities. For example, the use of our parks and buildings to provide extra curriculum opportunities.
- Look at all our Buildings and usage. In particular the options/ideas for the Old School and Compass Building. For example:-
  - Co-working opportunities
  - Office space for Small Businesses
  - Spaces for charities/local community projects
  - Early and Adult Learning Groups
- Look at assisting with the future promotion / recruitment of the Youth Council in the town now that Lockdown restrictions have been lifted.

# **Facts and Figures**

- The Youth Council is actively recruiting for new members and since lockdown has been lifted in one month managed to attract 3 new Youth Councillors.
- The Cylch Playgroup has vacated part of the Old School at the beginning of March 2022. The council have already had many enquiries from other Nurseries / Organisations to take over the hire of this facility.
- Three wedding were undertaken in the Council Chamber in 2021. At present for 2022 the following wedding events have been booked:
  - o 1 civic service in the Council Chamber
  - 1 Wedding Reception in Town Hall
  - 4 civic service in Council Chamber followed by Reception in the Town hall

# **A Resilient Llantwit Major**

#### What we did well

- The Planning Committee have continued to work hard to review and comment on all Planning Applications relating to our wards. They adhere to the latest Welsh Government Planning Regulation Guidelines, Vale of Glamorgan Council Local Development Plan, Conservational, Ecological and Environmental recommendations, and guidelines. A site visit is undertaken for any Planning Applications considered sensitive / unsuitable to the area.
- The Planning Application relating to TPO tagging, although not required to be reviewed by the Town Council Planning Committee are continually checked and monitored to ensure our town is adhering to all the environmental and conservational guidelines with reference to tree preservation.
- The Allotment site continues to gain popularity during 2021 there was over 30 people on the waiting list. When tenants have vacated their plots (if over a set perch size) the Town Council have restructured them into smaller, more manageable plots thus offering additional plots to the community. At present there are 106 plots on the Llanmaes Road Allotment Site.
- Continual maintenance of our listed buildings adhering to CADW guidelines.
   Work included
  - Repairing, removing old plaster on the internal walls of the Old School to deter the continual damp problems within this historic building.
  - o Repairs to the external stone walls worn down by the weather etc.
  - Repainting and revarnishing doors/windows/internal walls to preserve the interior and exterior of the building whilst ensuring all relevant listed building consent is followed.
- The Town Council completed Topple Testing in Boverton Cemetery and repaired all graves stones recorded as unsafe. Thus, ensuring the preservation of the graves in the cemetery for the future.
- Stradling Park This is in the final phase of the Asset Transfer of this overgrown/neglected park from the Vale of Glamorgan Council to Llantwit Major Town Council. The overall aim is to create a safe / quiet / environmentally friendly area for residents of the town.
- Continuous maintenance of equipment in the two children's play parks and adult sports equipment on the Recreation Field. A new area of mulch has been installed under some of the children's play equipment and the play equipment in the U10'S playpark has been repainted.
- Monitored all the trees and hedgerows in the parks and land owned by the Town Council. Extensive work has been undertaken on the Allotment Site to remove old hedges/trees/shrubs to preserve the old stone wall and create a safer entrance to tenants and pedestrians entering leaving or walking past the Allotment entrance. A Grant was successfully obtained from Welsh Government to purchase two skips on the Allotment site for tenants to get rid of all unwanted building materials from their plots and re-shingle the pavement and carparking area on the site.

#### What we think we could do better

 Continue to Work closely with outside parties and the local community to encourage sustainability.


#### What was said about us

# A Healthier Llantwit Major

#### What we did well

- •The Town Council continued to support the town throughout the coronavirus pandemic. The Town Hall was open to provide continued support to the public. Reopened (adhering to Government guidelines (reference numbers and social distancing)) Llantonian Hall and the Town Hall to our regular Hirers whilst ensuring all PPE equipment on site, cleaning rotas are maintained, and Health and Safety Risk Assessments are in place.
- Obtained a Vale of Glamorgan Council Community Trust Grant to install three additional pieces of adult play equipment on the Recreation Field.
- Supported both administratively and financially the Tennis Club to ensure funding in place for the installation of Floodlights on all four tennis courts on the Recreation Field. A Field in Trust Gant of £10,00 was obtained towards the overall project goal.
- Opened and maintained throughout last year 2 play parks on the Recreations Field.
   Repaired various play equipment and resurfaced areas of mulch with the play parks.
- Allowed local children's activity groups to run outdoor classes on Seaview Park and Lorna Hughes Park to encourage healthy living.
- Hearing loop system installed alongside PA system in Llantonian Hall to provide those with hearing difficulties the opportunity to attend, enjoy and participate in events put on in the Hall.
- To continue to work and support and further develop relations with external clubs and organisations that hire/use the Recreation Field (i.e., Rugby Club / Bowls Club / Tennis Club).
- The Town Council continued to support Parkinson Group and Local Age Connect with reduced hiring fees to support and promote activities for the elderly and vulnerable within our town.
- The Town Council have successfully installed new seating along Llanmaes Road providing a place for those to rest or sit and chat. The Town council also support a 'Happy to Chat Bench' outside the Town Hall to provide a place where those feeling isolated an opportunity to connect with others in the community.
- The Town Council continue to support all their employees by funding and providing opportunities for all members of staff to meet with a qualified Councillor re work related stress/ pandemic issues.
- Continue to maintain and run a Defibrillator in the Red Phone Box in the Cenotaph Square. Also provide on our Notice Boards a detailed list of where all Defibrillator's are situated around the town.

#### What we think we could do better

- Continue to work with the Vale of Glamorgan Council and other local organisations to provide and promote activities for children after school and in the school holidays.
- Ensure we continue to provide safe playground equipment in our Parks and always look at improving these areas and where possible ensure inclusive usage.
- Look at further Grant funding opportunities to provide free fitness classes /activities/equipment for all ages of the Community.
- To improve communication and links with all schools/clubs etc to make them aware of the facilities the Town Council can offer to help make Llantwit Major a healthier town.
- To review and find further ways to promote the Town Council facilities and achievements throughout the community.

#### **Facts and Figures:**

- Over 100+ young people / adults regularly use the newly installed equipment on the Recreation Field.
- Over 60+ people at events ran in Llantonian Hall (e.g. groups such as the Horticultural Society / History Society) now have the opportunity to use a PA system / Hearing Loop system.
- Over 30+ elderly people regularly attend Age Connect Well Being / Keep Fit Classes in Llantonian Hall on a weekly basis.
- The Stoke Association /Music in Min and Parkinson Group have regular Meetings in Llantonian Hall supporting those on our community with suffering with these debilitating illnesses.



# A More Equal Llantwit Major

#### What we did well

- The Town Council successfully awarded grants to the following local groups to provide additional funds for them to maintain and run their organisations. Grants for 2021/22 were awarded to:-
  - Llantwit Major Christmas Committee
  - Llanilltud Fawr in Flower
  - Llantwit Major Festival of Arts
  - Llantwit Major Music Festival
  - Llantwit Major Photography Club
- The Town Council ran a Remembrance Service event for the town, whilst
  adhering to protect the members of the public during the ongoing coronavirus
  pandemic by reducing the numbers allowed to march, ensuring social distancing
  at the Cenotaph and providing a live stream for those unable or uncomfortable
  with attending the service in person.
- The Town Council supported by Filco Food Stores produced a 'Llantwit Major in Lockdown' Book depicting our towns experiences throughout the pandemic 2020/21. Any proceeds from the book are to be given to a local group that are travelling with vital aid to support the citizens of Ukraine in their conflict against Russia.
- The Council continue to support many local organisations in the town that provide valuable services to the community. This include the Christmas Light Committee, Age Connect, Town Twining Committee, Stroke Association, Dementia Friends and Fair Trade.
- The Town Council have worked tirelessly this year with the Vale of Glamorgan Council and local landowners to continue to try to re-establish the public footpath in Trebeferad.
- The Town Council are continuing to liaise with the Vale of Glamorgan Council re the asset transfer of Stradling park to Llantwit Major Town Council.
- The Town Council have supported the Mayor, Councillor David Powell's chosen charities (the youth organisations of Llantwit Major). Despite the difficult times with the pandemic the Mayor ran a very successful afternoon tea part on his Farm. From this and other events he managed to give £500 to both Llantwit Major Scouts and Brownie Groups.
- The Town Council, with the support of the Town Twinning Committee, continue to redevelop links and friendships with their twinned French town of Le Pouliguen.and plan a trip to Le Pouliguen in late summer.
- The Town Council give reduced rates to the History Society to ensure they have a room at the Old School to hold all their archive material and run a very popular Historical Society.

#### What we think we could do better

- Continue to support inclusive play equipment when upgrading play equipment.
- Continue to look at ways to provide access to the main hall in the Town Hall.
- Continue to develop links with businesses to work together to improve the town and increase its footfall.

- The Town Council offers reduced rates on all its facilities for those using them to raise funds for charitable organisations or those holding weekly/monthly event classes for those which help residents.
- 5 Grants were handed out to local organisations.

# **A Llantwit Major of Cohesive Communities**

#### What we did well

- The Town Council provides the Compass Building as a co-working facility.
   Offering local businesses office space at cost effective prices.
- A new hearing loop installed in Llantonian Hall to assist with those with hearing difficulties.
- A Fire Alarm System was installed in the Sports Pavilion of the Bowls Club, providing additional safety for hirer and members.
- The Town Council had their first wedding in the Council Chamber in 2022, adhering to Welsh Government guidelines. In 2022 there are 5 civic services planned in the Council Chamber and 5 wedding receptions in the Town Hall. Providing cost effective venues for residents of our town in the historic hub of the community.
- Topple Testing was undertaken at Boverton Cemetery. Any unsafe memorial stones were repaired and funded by the Town Council. If the plot owner did not had sufficient funds, or was unable to be contacted to ensure the works were completed. Providing a safe and well-maintained area that provides comfort and support to so many.
- The Town Council successfully installed four Fairtrade signs onto the Welcome
  to Llantwit Major Road Signs. Thus, informing residents and visitors to the town
  of our Fairtrade status. In February 2022 the Town Council again supported the
  Vale of Glamorgan's initiatives to promote Fairtrade fortnight and held a stall on
  the Precinct in the town to further forward our fairtrade ethos.
- Funded, set up and established IT equipment in the Council Chamber to permit
  Hybrid Council Meetings to be undertaken, adhering to all Welsh Government
  Regulations. The First Hybrid Meeting (Planning Committee) was held in the
  Council Chamber in February 2022 and the First Full Town Council Meeting was
  held on the 31<sup>st</sup> March 2022.
- All Works and Tenders (where possible and financially viable) are undertaken by local companies. Supporting businesses within our community.
- The Town Council continue to use website/social media platforms/Quarterly Newsletters and Notice Boards to publicise Council and Community News and Events. Continuing to develop the 'Birth/Marriage & Deaths Notice Board in the Precinct and applied for a Grant to look at installing a Digital Notice Board in the town centre to further promote local news, events, and jobs within the area.
- The Town Council continue through Town Study Group and external organisations to look at ways to promote footfall, businesses, tourism to the town. We have worked with the Vale of Glamorgan Council to provide banners and flags throughout Llantwit Major and developing the 'Love Llantwit Major' theme.
- Continue to work with Vale of Glamorgan Council re the asset transfer of Stradling Park to Llantwit Major Town Council.

#### What we think we could do better

 Continue to improve the Town Council profile through Multi-media social network sites (e.g., start using Twitter). Find alternative ways to promote Town Council news (e.g., further Quarterly Newsletter/Flyers) to promote Councils Policies and activities now that the local Newspaper has closed down.

# A LLANTWIT MAJOR OF VIBRANT CULTURE AND THRIVING WELSH LANGUAGE

#### What we think we did well:

- All new signage (e.g., on the Recreation Field and Fairtrade is printed bilingually in English and Welsh.
- Town Councillors continue to support the newly formed Town Twinning Committee to further encourage and develop links with the French town.
- The Town Council organised a Remembrance Day Service around the Cenotaph whilst adhering to Government Guidelines re Covid 19. Each organisation of the town was allowed a representative to lay a wreath at the Cenotaph. This was 'live streamed' giving an opportunity for all residents of the town to be part of the Service.
- The Town Council continue to care and maintain their listed Buildings (Town Hall, Old School and Cenotaph) working with CADW and the Vale of Glamorgan Council to ensure the buildings comply with the architectural/historical regulations/guidelines.
- The local History Society house their archive room in one of our premises. The archive room is open once a week to residents and visitors subject to Government Guidelines.
- Banners, Flags, Canvas Bags, Car Stickers for promoting tourism within the town area bilingual (half printed with Welsh wording and half English wording)
- All Posters for Council Meetings are Bi-lingual and all Minutes and Agendas on request can be translated into Welsh.
- A member of staff is a fluent Welsh speaker.
- Any incoming telephone calls to the Town Hall are answered in both Welsh and English.
- The Town Council continually review the Council's Welsh Language Scheme.
- A project is being undertaken in April 2022 by the Town Council to install lighting at the front
  of the Town Hall building. This will emphasise the importance of the building to the town and
  highlight the historical structure of the building.

#### What we think we could do better:

 Re-establish stronger links with the Town Councils of Le Pouliguen, France and Llantwit Major.

- The Town Council Staff and Councillors try to improve their knowledge and use of the Welsh Language.
- The Town Council Staff improve their knowledge of the history of Llantwit Major for visitors that come into the Town Hall for tourist information.



# **A Global Responsible Llantwit Major**

#### What we did well

- The Town Council at present have 106 Allotment Plots on their Llanmaes Road Allotment Site. Popularity over the last few years have increased with at present over 20 people on the waiting list. When plots become vacant, they are reviewed to see if they can be split to provide extra plots for the residents of our town. Further encouraging the growth of your own fruit and vegetables while adhering to eco and bio friendly processes.
- The hedgerow has been carefully trimmed and all rubbish / debris removed from the site. The ivy/ hedgerow has carefully been removed from the stone wall running along Llanmaes Road. The damaged wall caused by the overgrowth is to carefully be restored by a specialist stone mason following traditional method and materials.
- A new bench purchased along Llanmaes Road is made from recyclable plastic.
- The Handyman twice yearly plants shrubs and flowers in areas owned by the Town Council. Two specific areas (Outside Llantonian Hall and at the bottom of the Recreation Field are designated wildflower beds to encourage bees and wildlife).
- The Town Council is in negotiation with the Vale of Glamorgan Council re the
  asset transfer of Stradling Park. To provide the town with an area that will be
  designated to being environmentally friendly. Also to encourage the town to be
  globally responsible and assist with achieving the Town Council objectives
  towards Project Zero.
- The Town Council have had meetings and attended presentations and done
  initial investigation into electrical car charging points within the town.
   Ascertaining, what as a local Council, we can do towards the 2030 Governments
  legislation re electric cars.
- The Town Council is working with the Vale of Glamorgan Council on the way forward to achieve their and our towns Project Zero goals and we will be finalising our aims over the next year.
- The Town Council continues to promote a plastic free / environmentally friendly town by:
  - a) Offer a water refill point in the Town Hall
  - b) Use Cardboard cup/straws at Council events
  - c) Encourage residents to purchase canvas 'Love Llantwit Major' shopping bags
  - d) Recycle weekly Town Hall Office waste
  - e) All shredded office paper utilised by Allotment tenants on their plots
  - f) All external / internal lighting and bulbs that needs changing, if possible, is replaced with LED or Solar Lighting options.
  - g) Recyclable dog poo bags can be purchased in the Town Hall Office by residents.
  - h) Litter Picks are daily undertaken in all our Parks and open space areas.
  - i) All cleaning products where possible are eco friendly

- The Town Council promote Fairtrade within our town and we use fairtrade products at events (e.g. tea, coffee etc) and administer the Fairtrade Forum. Promote fairtrade fortnight and are looking at providing leaflets around the town which depict what businesses sell/use fairtrade products.
- Provide an Annual Grant to Llanilltud Fawr in Flower to provide flower displays/bedding plants around the town.
- The Town Council Planning Committee look at all TPO Planning Application requests
  within our town. Although not technically part of Town Councils remit the importance of
  querying trees felled within the town is considered by the Council to be of great
  environmental importance and hence the reason the Planning Committee question
  some TPO Applications.
- Planning Applications that are considered unacceptable to the environment / area are
  objected to. Over the last few years, the Planning Committee have studied and related
  objections to specified Welsh Government Planning Regulations and Vale of
  Glamorgan Council LDP policies when the council believe that the proposed
  Application does not preserve the natural and conservation area of our town.
- We work with Plant Llantwit and other organisations to encourage the replanting of trees/shrubs within the town.
- West Street Pool is maintained and annually cleaned to preserve the natural environment, wildlife and fish that exist in the pond and give pleasure to residents and tourists visiting the site.
- The Biodiversity Policy has been updated and adopted in 2021

# What we think we could do better:

- Continue to look at ways to find alternative fuel supplies for our buildings to further progress our environmental/ecological policies of our Council.
- Look at ways to further recycle / waste management of our resources.
- Continue to promote and encourage the growth of fairtrade within the town.
- Work with local organisations and Vale of Glamorgan Council / Welsh Governments in working towards the 2030 Project Zero goal.
- Continue to look at ways to maintain our hedgerow's and trees and encourage new growth.
- Use Stradling Park as a Project to ensure organisations come together to provide a
  globally responsible area for the town that can educate and work with all age categories
  of the community.

#### Facts and figures

- There is over 106 Allotment Plots and over 20 people on the waiting list for an Allotment
- West Street Pool has over 5 species of wildlife around and inhabiting the pond.

#### What was said about us:

"Dear Mayor and Llantwit Major Town Councillors I would like to take this opportunity to thank you for supporting the residents in their objection to the ongoing Wine Street Planning Application. Like many others, I felt compelled to move to Llantwit Major because of the extraordinary beauty and uniquely preserved historical character of its town centre. # A COMPETENT LLANTWIT MAJOR TOWN COUNCIL

Within the Welsh Governments Local Government Wales Act 2021, there is a section *General Power of Competence*. This Bill is aimed to bring more consistency to Town and Community Councils, developing a higher standard of governance and financial management controls.

Under the General Power of Competence regulations, a Town Council must ensure:

- Two thirds of Councillors must be elected Councillors must be elected at either an ordinary election or a by-election.
- Requirement that the Clerk is qualified A Clerk with relevant professional qualifications, such as the Certificate in Local Council Administration (CILCA).
- Council needs to have clear audited accounts for the last 2 years sound financial management and internal control systems.

To ensure the Town Council meet these requirements regular internal/external audits are undertaken and it can be noted in this Annual Report that:

- 14 members were elected by an ordinary election held in May 2017.
- The Town Clerk holds the CILCA qualification.
- All Town Council staff are up to date on all relevant courses in relation to their job specification.
- We have a sound management and financial controls in place which are reviewed annually.
- In addition, we have a website that is regularly updated containing all agendas, minutes, reports, accounts and contact details.
- The Deputy Town Clerk obtained the CILCA Qualification in April 2021.
- All Town Council Staff in 2021 undertook an online First Aid training course and are qualified for the next 2 years to provide First Aid in the workplace.
- All Town Council Staff undertake any relevant courses / presentations to ensure they
  are up to date with the latest local and government regulations so that they can carry
  out their job specification / role/ responsibilities both legally and to the best of their
  abilities.

# **Our Llantwit Major - Our Future**

In Chapter 1 to 8 of the Annual Report has concentrated on the National Well Being Goals as set out as in the Well Being Future Generation (Wales) Act 2015. The Vale of Glamorgan Council has also adapted their policies to include four local Well Being Objectives. These being:

- a) To enable people to get involved, participate in their local communities and shape local services.
- b) To reduce poverty and tackle inequalities linked to deprivation.
- c) To give children the best start in life.
- d) To protect, enhance and value our environment.

The next pages detail these objectives and how, we as a Town Council, intend to work towards meeting these local goals.

# To enable people to get involved, participate in their local communities and shape local services.

This objective is to enable people to become involved in their community, help to increase a sense of belonging within the Town, increase satisfaction with life in general and ensure that Llantwit Major is confident and their voices are heard within the Vale of Glamorgan.

#### What we have done so far?

- 1. The Town Council administer the Town Study Steering Group. Representatives from various organisations within the Town meet to develop and implement ideas to improve Llantwit Major. A Vale Councillor sits on the Committee to pass updates back to the relevant Vale of Glamorgan Council Departments.
- 2. The Town Council continue to actively support the Chamber of Trade and work with local businesses and the Vale of Glamorgan Council to improve and shape local services within the town.
- 3. The Town Council provide Grants to assist with funding local organisations (e.g., Christmas Committee, Llanilltud Fawr in Flower) to continue to provide a service to the community.
- 4. Town Council continue to support many local organisations including Fair Trade Forum, Plant Llantwit, Chamber of Trade, Town Twinning Committee, Llanilltud Fawr in Flower, Christmas Lights Committee, the Tennis Club and the Bowls Club to assist with their continuation and further development.
- 5. Liaising with Vale of Glamorgan Council to improve the town of Llantwit Major for our residents.
- 6. Provide the Compass Building as a site for co-working, opportunities for local businesses Offering affordable office space on a short term basis.

#### What will take longer to achieve?

- 1. To continue to try and improve relations with organisations and businesses within the Town and find ways to get more people involved within their community. Our newly recruited Events Coordinator Administrator, start date 1<sup>st</sup> April 2022, goal will be to develop relations with local organisations to encourage them to work together for the benefit of the town.
- 2. To continue to support local organisations and businesses (such as the Chamber of
  - Trade, Llantwit Major Dementia Friends, Fair Trade Forum, Plant Llantwit, Christmas Light Committee, Events Group etc).
- 3. To further promote our Town Council facilities and Parks to provide opportunities of organisations within the community to tackle isolation, loneliness and making healthy

lifestyle changes. To provide further opportunities via the Town Council facilities to implement better services for the Town.

# What will success look like in 2023?

- 1. Skills, resources and expertise regarding engagements are shared across organisations for the benefit of the town. Getting organisations to work together for the benefit of the community.
- 2. Contributions of all age groups are recognised within the local community.
- 3. Volunteers are encouraged and feel valued.
- 4. Sharing standards for engagement are developed.

# To reduce poverty and tackle inequalities linked to deprivation

Llantwit Major is a comparatively wealthy town and many residents enjoy a high standard of living in a safe and attractive environment. However, there are still areas within the town that experience disadvantage, low education achievement and higher unemployment levels.

# What have we done so far?

- 1. Successfully gained a grant to install a further 3 pieces of adult gym equipment in the Recreation Field available free for use to any resident over the age of 14.
- 2. Successfully assisted Tennis Club in installing floodlights on all four tennis courts enabling play all year round and in the evenings, for our town.
- 3. Continually improving and maintaining play parks for children in our town and where possible offer inclusive play equipment. Providing free play equipment in peaceful surroundings with benches and picnic areas for families to entertain their children.
- 4. We offer reduced rates to various organisations who hire our venues (e.g., Parkinson's Group, Stroke Association). We also offer reduced rates for all Charity organisations hiring our facilities.
- 5. We offer Annual Grants to organisations to ensure Community Groups are supported (e.g., Llanilltud Fawr in Flower).
- 6. We provided a 'Happy to Chat' Bench outside the Town Hall. A place where those in a vulnerable position can sit, talk and be offered support by residents of the town. Also an additional bench was installed along Llanmaes Road for those with walking/ health difficulties to sit and rest prior to continuing up/down Llanmaes Road
- 7. Continue to provide 106 Allotment Plots at very low rates for residents of the Town. This includes providing plots for local organisations (e.g., Plant Llantwit) and locals with learning disabilities, to provide a place where they can learn new skills at affordable prices. The average price of an Allotment plot for a year in 2021 was £13.00, this includes water rates and general maintenance and cutting of the paths by the Town Council.
- 8. Provided a hearing loop system in Llantonian Hall to provide those with hearing difficulties ability to hear events / presentations in the Hall.
- 9. To continue to provide an affordable venue for our residents to hold a wedding ceremony and reception. Total package to hire Council Chamber and Town Hall is £500 for the weekend.

# What we can start doing today?

To continue to source Grant and Fund opportunities to provide additional services and community events for our town.

To liaise with the community (i.e., through written questionnaires and social media apps) on how as a Town Council we can improve our town and tackle inequalities within our community.

The Town Council continue to work with community groups and businesses at ways to improve the services within our town.

To start again to provide community events for the town now that the pandemic restrictions are lifting (e.g., Annual Pantomime, Citizen Awards Event, Open Air Cinema event) for all sectors on the community encouraging social and educational learning.

Promote more widely the Town Council facilities. To publicise and advertise our Halls to encourage the community to take part in classes ranging from Yoga to History Presentations.

Work with the Vale of Glamorgan Council Youth Services team to provide more activities (e.g., sports clubs, holiday camps) for the children of Llantwit Major.

To continue to work with Vale Youth Services to promote and recruit new members for the Youth Council of our town to make the council investment to this service economically viable.

# What will take longer to achieve?

- 1. Working together with all organisations / businesses of the town to improve equality in the Community.
- 2. Continue to look at ways to improve our environment (e.g., working with Plant Llantwit, Vale of Glamorgan Council).
- 3. Use our facilities further to provide better use of our facilities for the under privileged and aged members of the community.
- 4. Continue to support and develop our play parks and sport facilities. Look at further funding opportunities to provide free sport activities for the community.
- 5. Look at providing Mobility access into the disabled toilet area of Llantonian Hall to make the hall move inclusive to all sectors of our community.

#### What will success look like in 2023?

- 1. The Community of Llantwit Major becomes safer, stronger, and more resilient.
- 2. Give residents a better understanding of how their contribution on the environment can make to their well-being.
- 3. Create a sustainable environmental project which brings a range of well-being benefits to the local community. Once the Asset Transfer of Stradling Park between the borough council and town council has been completed in 2022 the Town council will be able to commence a project to fulfil this brief (i.e., the regeneration of Stradling Park, an overgrown park in the heart of Llantwit Major).

### Give children the best start in life

Working together to ensure all children within Llantwit Major have the best start in life and the inequalities that exist within the Town are reduced.

Also improve the wellbeing of parents and carers of young children who have such a big influence on their development.

#### What we have done so far?

- Maintained and developed two Children's Playgrounds within Llantwit Major and developed one teenager Gym Equipment area on the Recreation Filed. Where viable will always provide inclusive play equipment for our children.
- The Town Council support the Youth Council financially to allow the children of Llantwit
  Major to have a voice within the Town Council, what vision they have for the future growth
  and development of the Town. Two Councillors regularly attend the Youth Council
  Meetings.
- 3. The Town Council support 2 Playgroups ran in the Old School by giving reduced rental rates.
- 4. The Town Council assisted various local organisations with Grants/ Funding (e.g., LM Tennis Club) so that they can provide after school activities for children of the Town.
- 5. The Town Council assisted the Tennis Club to install floodlighting on all four tennis courts. Providing opportunities for play all year round and provide opportunities for other sport groups/organisations to use the area for after school activities.
- 6. Gave free access to children's organisations to use our open spaces/park areas to provide outdoor workshops and playschemes to children. Thus, allowing activities to be undertaken for children during the pandemic.
- 7. Assisted Primary School education in Llantwit Major by providing tours of the Town Hall including access to the Cellar and Clock Tower.
- 8. Encouraged children to participate in various events organised and ran by the Town Council including:
  - (i) To draw pictures, write articles and poems for the Llantwit In Lockdown Book
  - (ii) A Treasure Trail around the town

#### What will take longer to deliver?

1. To work with the Vale of Glamorgan Council to offer Town Council facilities to provide better and more regular Play Scheme Activities for Llantwit Major children during all holiday periods and provide additional after school clubs for children (e.g., children's running groups, girl's netball etc).

- 2. Continue to work with the MOD St Athan and Annington Homes to look at creating a Play Park for teenagers at East Camp/ St Athan on the old disused Tennis Court site.
- 3. To continue to work with external organisations to provide activities for children (e.g., Sport, music, education) utilising fully Town Council facilities to create better well-being for children and parents.
- 4. Support and assist Vale Youth Services to enhance and recruit members to the Youth Council and other events the Vale run in Llantwit Major for the teenagers of our town.

# What will success look like in 2023?

- 1. We all understand how our organisations activities can contribute to giving children a good start in life.
- 2. Individual families and communities in Llantwit Major becoming safer, stronger and more resilient.

# Protect, enhance and value our environment

As a Town Council must collectively take action to protect, enhance and value our environment for now and future generations, ensuring as a town we are globally responsible.

# What we do now?

- 1. All are open spaces are registered as Field in Trust Sites.
- 2. The Town Council are in the process of working with the Vale of Glamorgan Council to complete the asset transfer to take over the running of Stradling Park, an area of overgrown wasteland and transform it with wildflowers and shrubs and create an open space/relaxation area for the residents of Llantwit Major.
- 3. The Town Council continue to support making Llantwit Major a plastic free town. They have produced 'Love Llantwit Major' Canvas Bags for people to buy and use, instead of purchasing plastic bags from retailers.
- 4. The Town Council have renewed the towns Fairtrade status. Encouraging shops and businesses to stock fair trade products and residents/local organisations to buy fair trade to protect our environment.
- 5. The Town Council offer a water refill point at the Town Hall.
- 6. The Town Council continue to run 106 Allotment Plots, providing opportunities for residents to grow their own fruit and vegetables. There is in 2021 a waiting list of 20 people.
- 7. The Town Council continue to maintain the towns historic monument, the Cenotaph. It is cleaned twice yearly. We maintain and repair our listed buildings the Old School and the Town Hall.
- 8. The Town Council clean annually and continually maintain West Street Pool to provide a healthy environment for the fish ,wildlife and plant life that reside in this pond.
- 9. The Town Council have started investigating electric charge points in the town, Looking at the viability of providing a charge point for our town to encourage residents re the benefit of running electric cars to protect our environment and move towards our project zero goal.
- 10. The Town Council have looked at the cost and feasibility of purchasing electric bikes for our town. To provide access for healthy living and reduce carbon footprint in our town.
- 11. Topple Testing was completed in the cemetery. All stones that were unsafe or damaged were repaired to ensure the safety and preservation of Boverton Cemetery over the forthcoming years.

# What will take longer to deliver?

1. The Town Council continue to work with various organisations to fulfil environmental projects for the Town. (e.g. working with the Fair Trade Committee and with businesses to continue to promote a Plastic Free Trade).

- 2. The Town Council continue to work with Plant Llantwit to establish a programme to replant trees and shrubs throughout the town.
- 3. Continue to look at projects to assist both with tourism and help the environment. Projects include Electric Bikes in the town, further bike trails and trying to establish and maintain footpaths in the town through the Footpath Forum Committee.
- 4. Continue to maximise the benefit of our environment by continuing to promote our town as a place to visit. Further develop the 'Love Llantwit Major' theme. Continue to try to develop Llantwit Major as a tourist town to visit in the Vale for walking, cycling, the beach, historical landmarks, shopping and place to come to eat and socialise. The Town Council need to develop stronger links with the Chamber of Trade, Businesses and local/national organisations to further promote and build our town status. A new member of Staff has been employed effective from 1<sup>st</sup> April 2022. Her role as Community Administrative Assistant is to get organisations to work together for the benefit of our town.
- 5. Further investigate electric charge points and bio-diversity fuels for our Council Buildings to assist with making our town Eco Friendly in coming years for the next generation.
- 6. Continue to adapt the Town Council assets to maximise their potential for community use as well as an environmental resource.
- 7. Continue ongoing maintenance to our listed buildings ensuring that traditional methods and Cadw and listed building regulations are always followed to ensure their preservation of our historic Council buildings.
- 8. Exterior lighting is to be installed at the front of the Town Hall enhancing our historic buildings for the residents and tourists visiting our town.

# What will success look like in 2023?

- 1. Continue to gain a better understanding of the impact of our actions on the environment and how much of an asset our local environment is.
- 2. To look at finding and funding a new area of land within the town to be developed into a new Cemetery for Llantwit Major.

# **Way forward**

This year's Annual Report has once again been impacted heavily by the continuing worldwide coronavirus pandemic. Despite the decrease in income and cost of living rising the Town Council have ensured that the Town Councils precept request has again remained unchanged from the previous financial year (i.e., £59.20, which is based on amount a band 'D' household would pay over the year to the Town Council).

Now that the Town Council have in place IT requirements for Hybrid Meetings the Town Council can now ensure all Meetings have functionality to be held within the Council Chamber or via Zoom (dependent upon the individual specific requirements).

The Town Councils main priority for 2022 is to ensure all our Buildings are fully utilised by regular hirers and tenants to ensure an increase in income for 2022/23.

The Town Council will aim to undertake various projects during the 2022/2023 financial year including:

External Lighting of the Town Hall

Investigate electric points for the town and alternative fuel options for our

Buildings (working towards Project Zero goal

A Two new memorial benches for around the Cenotaph

Full cleaning and repairs to Town Hall Clock / Repair of chime mechanism

Fence line Illtyd Avenue

New boiler Llantonian Hall

Disabled Toilets Llantonian Hall

The Town Council will also have the challenges of a newly elected Town Council from the 5<sup>th</sup> May 2022 and the additional workload this will impact on Councillors and Staff. The Town Hall Staff must further endeavour to inform our community of our new elected Councillors whilst ensuring that are fully trained and understand their duties, roles and responsibilities.

Town Council Staff must also ensure that they follow the new Training Plans that have been developed for each individual.

Government legislation if being continually updated and Council staff and Councillors must ensure that this is followed and endorsed. For example the General Power of Competence (Local Government and Elections (Wales) Act 2021) that comes into force on the 5<sup>th</sup> May 2022 which allows:

"Qualifying Local Authorities to "act in their communities' financial interests to generate efficiencies and secure value for money outcomes and to take on financial risk. It would also enable authorities to have greater confidence in pursuing innovative policy solutions than relying on the well-being power"

There will still be challenges to be faced with the United Kingdom's exit from the EU. The impact of Brexit (and Coronavirus) will undoubtedly continue to have an impact on funding for both the Borough, Welsh Government and United Kingdom.

The Town Council in the 2022/2023 year must continue to promote themselves within the community. They must act as a catalyst to encourage all businesses and organisations to work together to promote Llantwit Major to increase footfall and tourism to our town to help our community to recover and grow.

The Town Council face another challenging and busy year but the aim is to continue in their goal to make the Town Hall the focal point for our community for the forthcoming years.

#### Environmental Projects within Town

The Town Council are working hard to improve the environment of our town and are committed to looking at future sustainable projects.

Over the last few years, we have planted wildflower gardens on the Recreation Field, outside Llantonian Hall and in Lorna Hughes Park. We have worked and supported Plant Llantwit. New sapling trees and hedgerows are being planted in Sea view Park.

The Town Council worked with the Chamber of Trade to offer water refill points in businesses/shops throughout the town. As a Council we are encouraging a plastic free town, encouraging hirers of our facilities to not use plastic cups/straws etc as well as recycle all their waste.

The Fairtrade Committee have also managed last year to renew the towns Fairtrade Status. Many of our local stores offer Fairtrade products for sale and as part of Fairtrade fortnight in March 2021 organisations ran Fairtrade remoted coffee mornings and schools took part in a Fairtrade competition 'choose the world you want'.

Future projects the Council will be looking at include the feasibility of installing an electric car point within the town. If you have any environmental ideas the Council could do to improve the town then please contact us at the Town Hall.

#### Improvements in the Town

- A new sound system in Llantonian Hall
- The renewal of safety surfaces in playgrounds
- The installation of adult fitness equipment in the Recreation Ground with 100% grants
- 2 New CCTV cameras in the Recreation Ground
- Using over 90% grant aid to install floodlights on the increasingly popular tennis courts.
- Plans are being finalised to floodlight the Town

  Hall

#### Grant Aid

Each year the Town Council award small Grants to many local organisations in the Town. In the past we have supported the Boys Brigade, Rainbows, Netball Club, Women Institutes, Parkinsons Club, Vale Plus, Ladies Choir, Scout Group and many more. Applications are welcome all year round and are considered in early January. Please contact us for an application form.

Larger grants are considered for charitable events in the Town, and the Town Council are proud that they have supported the Llantwit Major 10K Committee from the very beginning and have continued to do so for the past 5 years, ensuring the continued success and growth of the 10K event held in August.

We also contribute yearly to the Christmas Illuminations in the Town. Each year those installing the Christmas Illuminations have been awarded a Grant to ensure the Town has its display for the festive period. Working closely with the Christmas Committee, in 2019 we were successful in a Grant application from the Vale of Glamorgan Council for the purchase of all new illumination and the installation of RCD boxes to ensure they could be safely installed, and the Town would be 'lit up' once again.

Last year we financially supported the RAF Voluntary Band with their open top bus being driven around the Town and surrounding area, bringing Christmas music to cheer residents up.

Each year we also financially support Llanilltud Fawr in Flower, awarding them a Grant to purchase and plant their annual flower display in the centre of the Town.

There are many wonderful, hard working voluntary groups and organisation in the Town, and we would like to thank them for all the work they do to ensure Llantwit Major continues to be the friendliest, community spirited Town to live. Pioloch!

#### Lockdown - March 2020

It is over a year ago we had the first serious lockdown and isolation. Although there may now be some light at the end of the tunnel those early days were very dark and uncertain.

The Town Council wishes to place on record its thanks to our small staff who immediately reacted to the situation and started delivering shopping and medical needs when little other help was available. They then organised a team of some 130 volunteers who gave up their time over many weeks to assist with the deliveries co-ordinated by Town Council staff.

Our sincere thanks goes to our staff and the volunteers who provided such essential services in the early days and weeks.









#### Town Council—What do we do?

We provide more services than any other Town or Community Council in the Vale of Glamorgan area. We are responsible for:

The Bowling Green and Pavilion, The Tennis Courts and Pavilion, The Llantonian Hall, The Town Hall, The Old School, The Under 10s play area, The Recreation Ground and the play area and adult fitness equipment, Seaview Park, Lorna Hughes Park, The Allotments and the Cemetery.

We are not responsible for potholes in the road or defective pavements but these can be reported to the Vale Council on 700111 or by email c1V@valeofglamorgan.gov.uk

#### Weddings

Liantwit Major Town Council have worked hard over the last few years to refurbish the Town Hall and make it popular place to hold parties, weddings, family and group celebrations, thus providing Liantwit Major with a venue to hold functions, in the heart of the community, at cost effective prices.

In 2018 the Town Council was successful in obtaining a licence to allow civic wedding ceremonies to take place in the Council Chamber, at the back of the Old School.

Less than 200 meters from the Old School is the Town Hall Building, an ideal location for the wedding reception/evening entertainment, holding a maximum capacity of 100. The Town Council hold a music and alcohol licence for the venue.

#### Remembrance Day 2020

It was clear early in the development stages of arranging the Remembrance Service in 2020 that things would be very different than previous years. Although we were unable to have a Parade through Town, we were pleased to be able to provide an alternative service which complied with Welsh Government legislation.

Organisations were invited to have a representative lay a wreath at staggered times. A live stream was provided to allow residents to view from home.

#### Council Tax

Llantwit Major Town Council has announced there will be NO INCREASE in its Council Tax for the coming year.

Financially this has been a very challenging year and successive lockdowns has meant the Council has lost £40,000 in valuable rental income from Llantonian Hall, The Town Hall etc. as well as spending unexpected sums on PPE at our various sites.

Despite this the Council has sought to look for savings throughout the year and as a result has decided not to increase the amount of Council Tax payable to it from April. This is not to say the bills arriving will not be more, as the Vale Council and the Police have increased their requirements and these form the majority of the bill you will receive.

It is likely we will be the only Town Council in the Vale Council area not asking its residents to pay more next year.

Not increasing our Council Tax confirms the Council's commitment to look after the people of Llantwit Major and provide quality services at affordable costs.
