#### 371. TO ELECT TOWN MAYOR.

Councillor D Powell welcomed everyone to the Annual Meeting.

Councillor D Powell asked for nominations for Town Mayor for the year 2024/2025.

Councillor Foster stated before nominating the new Town Mayor he wished to express his thanks to the outgoing Mayor (Councillor D Powell). Councillor Foster stated he had controlled all the Council Meetings extremely well. He noted he had been a great Ambassador for the town and had organised some successful functions including a Town Twinning Event (for Le Pouliguen visitors) in the Town Hall and Carols in the Barn Concert. Councillor Foster stated that despite the Mayors consort (Mrs Gill Powell) suffering from ill health (this year) she still manged to attend many functions with her husband. Councillor Foster expressed Councillors vote of thanks to Councillor Powell and his consort Gill Powell for their Term in Office.

Not only was he a GP, Health Advisor, Lecturer he has also recently completed a Doctorate as well as being an active and hard-working Town Councillor. **RESOLVED:** That Councillor Dr Dickson is duly elected Town Mayor for 2024/2025.

The Chains of Office were invested to Councillor Dr Dickson.

Councillor Dr Dickson then proceeded to read and sign the oath as newly elected Town Mayor.

Councillor Dr Dickson thanked Councillor Foster for nominating him. He thanked, the Town Councillors and Staff for their support especially being a relative new comer to the town. He thanked Councillor D Powell and Mrs G Powell for all they have done during their term of office. He stated he was very proud of becoming Town Mayor and was looking forward to promoting the town. Councillor Dr Dickson confirmed that his chosen charity for his term in Office would be the National Coast Watch Institution based at St Donats Bay as well as supporting the restoration work of historic Wells in Llantwit Major (Samson Well and Midwell).

Councillor Dr Dickson confirmed his consort during his time as Town Mayor would be his wife Dr Sue Dickson.

Councillor Dr Dickson presented Councillor D Powell with the heraldic shield and past Mayor's badge.

Councillor D Powell addressed the Meeting. He said that it had been a great honour to be Town Mayor of Llantwit Major for a second term and was proud to promote Llantwit Major as well as overseeing various events. He was honoured to be part of both the Kings Gun Salute and part of the official closure of RAF St Athan. Councillor Powell wished to thank Councillors and his wife Gill (his consort) for all the support they have given him during his term in Office. Also, he wished to thank Councillor Dr Dickson for undertaking duties on his behalf whilst in his role as Deputy Town Mayor.
