Mr David Thomas thanked Town Councillors for the opportunity to address them in relation to the Eagleswell Development.

I have a note from our Barrister, Mr William Webster, which I will read out 'I would like to highlight to you that litigation is always uncertain as you are reliant on the discretion of a third party decision maker. On the other hand, If I thought that the case was without merit I would not be advising you to press on. The development is wholly wrong in principle with the council taking a benefit that has accrued entirely from its unlawful conduct. If this development had not already been built out the prospects of grant, even a temporary grant is zero'.

As I am sure you are aware, a very large number of Llantwit Major residents are frustrated with how we have been treated and continue to be treated, both by the Vale council and the lack of representation we have had on the council, despite having 2 cabinet members.

Hopefully you have all seemed fit to watch last Friday's planning meeting where it all came to a head. I say planning meeting, it actually was allowed to be turned into a meeting on homelessness with a disregard to the numerous issues with the actual design of the site.

I have to say it was very difficult to sit in the room where we, as residents of Llantwit Major, were ridiculed by one particular member of the committee. He said the site was basically lovely and resembled a holiday camp and couldn't see any problem. The councillor went on and said what he had heard in the meeting was a nonsense. Hopefully you don't feel what I am saying tonight is also a nonsense.

How can our local representative on the committee, knowing the strength of feeling and a large part of the community he represents, not be incensed by such a statement. Why didn't he call the said committee member out and at least say our objections had at least some merit.

I must tell you, the current elected council in Barry are laughing at the people of Llantwit Major. They are laughing at this council. I doubt if the majority of the planning committee even read your letter which was in the documents, or the letter from our new MP, let alone any of the close to 100 pages of evidence.

It appears the council has the undying support of 4 Llantwit First Vale Councillors. What benefit have the people of Llantwit Major had from our councillors having the balance of power in the vale, absolutely nothing.

At the planning meeting, one of our local members said the people of Llantwit Major had no confidence in the Vale council. Well, I can assure you, a large portion of the people of Llantwit Major have no confidence in our locally elected representatives who have stood by and allowed this to happen.

Please, during your debate, can we hear from all councillors, to hear where they individually stand regarding the development. As stated at the planning meeting, the objections read out by one of our councillors was not a party statement.

The leader of your group voted for the development. There is only one implication that can be drawn from that. Does the leader even take into consideration the feelings of his fellow group members or is he more influenced by the Leader of the council?

Our barrister has emphasised that an action brought by this town council will carry significantly more weight that an action by a few individuals.

We all look forward to hearing the upcoming debate and hope you see fit in offering your support by taking forward this legal action on behalf of our community and really showing that Llantwit Major Town council really does care about its constituents & our beautiful town.

To finish, I want you all to ponder something. Come with me on a trip into the future to 20th July 2029, I've invited you all to my house. We are standing in my daughter's bedroom (hopefully she has moved out by then). We can see a lovely green field once again on the Eagleswell Site. That is condition 1 on the approved planning application. Do any of you believe or trust current the Vale council to deliver that? I can assure, we as a group, do not.
